Message from CAO/Chair

The year began with an extended period of working from home with restrictions on gathering sizes, a prohibition on certain types of activities, and requirements to follow various precautionary procedures. But, as the year progressed into the summer months and restrictions eased, we began to get a glimpse of a new normal.

At Otonabee Conservation, 2021 was a year that required us to be creative and flexible in how we did our work.

We continued to migrate our services to on-line platforms. Customers can reserve a campsite and make an application for a Sec. 28 permit on-line. Many of our educational programs were delivered virtually.

We made greater use of our website and other social media platforms to communicate information about our programs and services. We saw increases in social media followers and subscribers to our monthly e-newsletter called, Your Watershed News.

We saw an increase in the number of people using our conservation areas. We launched an online visitor survey to gather information about their experience and suggestions for improvements.

We launched our first major fund-raising campaign since the former Otonabee Region Conservation Foundation wound up in 2018. The Your Meters Matter campaign raised over \$23,000 in the first 5 weeks of the campaign. The money raised will be used to revitalize the Jackson Creek Trail.

We responded to a year over year increase in the number of planning and permitting inquiries and permit applications. We processed 401 Sec. 28 permit applications, an increase of 25% from the previous year. We adopted new service standards for issuing permits and began tracking and publicly reporting on how well we were doing in meeting these standards.

We completed our Climate Change Strategy and began implementing some of the key actions identified in the Strategy. We will be issuing our first progress report this spring.

We continued to focus on keeping people and property safe, we issued 16 flood related messages and responded to drought conditions. We continued to support our municipalities in the delivery of the Clean Water Act by providing the Risk Management function and education programs and achieved a major milestone this past year with the completion of all the required risk management plans.

Our staff have worked very hard under very difficult circumstances, to fulfill our mandate of protecting people, property, and the natural environment. Our Board provided thoughtful leadership and direction through this unprecedented time. We wish to thank both the staff and the Board for their dedication to our mission and for their support for each other as we collectively met the challenges and opportunities of the year.


About Otonabee Conservation

Otonabee Conservation is a locally-focused, community-based environmental agency that protects, restores, and manages the natural resources within the Otonabee Region watershed. We work with our eight member municipalities to maintain a healthy, environmentally-diverse watershed that improves the quality of life for residents, makes our area more appealing to visitors and new business, and helps to ensure a more vibrant regional economy.

Otonabee Conservation delivers programs and services that support the sustainability of the environment, within the physical and economic context of the watershed and in consideration of the social, cultural, and economic aspirations of its residents.

We work closely with our member municipalities, watershed residents, and many partnership agencies to achieve program outcomes that balance a diversity of needs and local conservation priorities.

Our Natural Hazards Protection Program safeguards people and property from flooding and other natural hazards. To do so, we offer important services such as plan review and permitting, natural hazards mapping, flood and drought monitoring, and dam operations.

We have a regulatory responsibility to ensure compliance with our Development Regulations, Ontario Regulation 167/06, and to represent the provincial interest to natural hazards under the Planning Act. In 2021 we saw a 25% increase in permit applications and a 59% increase in the number of permits issued.

We operate Flood Forecasting and Warning system and monitor watershed conditions to detect low water conditions; in 2021 we issued 16 flood messages and 2 level 1 low water conditions.

We educate watershed residents about how to be safe and respond to natural hazards that may impact them; in 2021, the Springwater Awareness program was delivered to 959 students in 47 classes at 7 local schools!

We own and operate 5 Dams. In 2021, repairs were made to 3 dams; the retaining wall was repaired at Hope Mill Dam, a deck extension and railing replacement was conducted at Warsaw Auxiliary Dam, and erosion remediation and embankment stabilization was conducted at the Warsaw Back Dam.

Otonabee Conservation supports the implementation of water quality and quantity monitoring programs in partnership with provincial agencies.

We collect groundwater quality and quantity samples at 11 sites as part of the Provincial Groundwater Monitoring network; surface water samples are collected at 16 sites as part of the Provincial Water Quality Monitoring Network.

Otonabee Conservation, acting under it's authority as the Otonabee-Peterborough Source Protection Authority, coordinates the local implementation of the Drinking Water Source Protection Program. We support municipalities, landowners, and the Trent Conservation Coalition Source Protection Committee to meet obligations under the Trent Source Protection Plan (TSPP) and the Clean Water Act.

The TSPP is 1 of 22 Source Protection Plans in Ontario. Under agreements with 8 municipalities, we operate the Risk Management Office and deliver an ongoing Education and Outreach program.

Conservation Lands

Managing and conserving lands for the protection of natural heritage features and values. Providing opportunities for outdoor recreation.

Otonabee Conservation ensures the proper management and stewardship of 4,187 hectares (ha) of land owned by the Authority.

We operate two campgrounds and 29 ha of recreational lands that are free day-use areas for outdoor activities including hiking, biking, nature viewing, boating, picnicking, fishing, hunting, and swimming.

In 2021, 25,477 visitors camped with us at our two campgrounds, Warsaw Caves Conservation Area (CA) and Beavermead Campground. This is an 11% increase from the previous year. We also saw at 21% increase in day use permits issued for Warsaw Caves CA.

460 ha of our lands are Areas of Natural and Scientific Interest (ANSI); 2,437 ha of our lands are forested, while 1,727 ha are wetlands.

We also undertake activities to conserve, protect, rehabilitate, establish, and manage natural heritage by planting trees and native plants, and naturalizing shoreline on our Conservation Lands.

Where appropriate, we manage some of our lands for resource development including commercial forestry, aggregate extraction, and agriculture.

Otonabee Conservation provides support and advice for private and public land restoration and stewardship activities, which contributes to a healthy watershed. This is often in the form of native plantings, habitat enhancement, and shoreline naturalization projects that are often undertaken in partnership with municipalities, schools, public agencies, and community service groups.

In 2021, our NEW Climate Change Strategy was finalized including a series of goals, objectives, targets and actions, and an annual report to track progress.

In 2021, we sold 11,475 native trees and shrubs to 101 local landowners through our Tree Seedling Sales Program.

We delivered events and presentations to foster awareness of climate change and the watershed environment. We delivered virtual environmental education sessions to 3,165 students in over 70 classes and we also delivered 4 in-person tree planting events with 104 high school students.

We also provided plan review and technical clearance support and expertise to assist 8 municipalities.




